

# CHILDHEADED FAMILY GETS HOUSE

A dream for a better house in a shack seemed far-fetched for 26 year-old Thabisile Maoko from Arckonhoek in Bushbuckridge as she also had to make sure that her siblings have something to eat every day. "I did not think that we would one day move to a better house because of our situation," she said. "Sometimes we would go to sleep on an empty stomach." Unemployed Thabisile is one of the beneficiaries of the 200 houses subsidised by government through the Enhanced People's Housing Process (ePHP) at various villages in the area. Her two siblings and children occupied a two roomed shack, in a dilapidated state, after their mother and father died in 2010 and 2012 respectively and also a situation which forced Thabisile to drop out of school. Three of the children are at school going age and heavily rely on government sponsored social grants. Premier,

Refilwe Mtshweni-Tsipane together with Human Settlements MEC, Mr Speed Mashilo on Friday, 06 August handed over the keys for their newly built house. "I am feeling much happy; this house will bring us dignity. It was not easy living in a shack that is in a bad condition. My children will be comfortable here and will now focus on their school work," Thabisile said. "Their situation was habitable for anyone to live under therefore we saw a need to do something to change their life. What we have also incorporated into this programme was the backyard gardening. So we brought all the necessities to make sure that they start up their own food gardening so that we do away with the issues of malnutrition in our communities. So each time they need something to eat, they do not need to be stranded trying to hassle for food,"



# ANGRY RESIDENT OF STEVE TSHWETE MUNICIPALITY

Angry resident of Steve Tshwete municipality took to the streets demanding a reversal of the new billing system that saw municipal accounts increasing by more than very alarmingly. The situation exploded into a civil unrest as residents blockaded main roads and streets with burning tyres and stones making it impossible for trucks, busses, taxis and light-motor vehicle to move in and out of Middelburg. The national route N4 and N11 were also blocked as protesters from Rockdale, Hlalamnandi and Nasareth also joined the bandwagon."We cannot afford to pay these rents," said Thabo Malatsi. "My rent increased from 326 to 960 and I do not know why."The municipality, in November last year, embarked on a data cleansing

project including a door-to-door survey for water and electricity meters and also updated its indigents register before end of 2020/2021 financial year. The Middelburg and Hendrina Residents Front (MHRF) has rejected the increases."We remain resolute against the increases on rates and taxes together with the manner in which the issue of indigent was dealt with," said MHRF spokesperson, Thato Mathunyane."We further indicated that this unrest was caused by ANC councilors who voted for the increase amidst Covid-19, without consultation-they cannot be immune-from the cause."He added, "The arrogance of the Mayor in making sure that Bheki khenisa does not leave our town in peace is also the cause hence he lost tremendously in his

Ward nomination which is an indication that his political career has reached a cul de sac."The Democratic Alliance (DA) appealed to council to reconsider the current billing system caused by the data cleansing of the municipal accounts. "We wish to call on council to sit and reconsider the delisting of some indigent recipients, inconsistent estimate billings from rectified accounts, leaving residents with an almost 300% increase on their accounts and the rescission of the resolution pertaining to the billing on refuse removal in some, but not all areas in the municipality,"said Johann Dyason, DA Causus leader in SteveTshwete. Steve Tshwete mouthpiece, Prudence Magutle told the paper the data cleansing project aimed at sending correct billing

information to customers whilst ensuring that eligible residents are on the list of indigents."Accuracy of customer details is required by our financial systems so that correct account details are sent to residents," she said."Updating the indigents list means that people must re-apply and only those who qualify, will be put back on the list." "In the new financial year that started in July, we adjusted our tariffs by an average 3.69% compared with the previous financial year which was 6%," she said. "This means that the municipality has had a minimal increase on tariffs because we considered the effects of Covid-19 on the residents such as unemployment."

Mpumalanga MEC for Human Settlement, Speedy Mashilo says his department is soon going to overcome the RDP housing scam involving an official eMalahleni municipality. "We are doing all we can stop this criminal syndicate and am happy that the official allegedly involved in this corruption has been arrested," he said. Mashilo added that the lack of verification has exacerbated the corruption. "Here you find that many people have leased the houses and some have rented and the actual owners are not there," he said. "We have compiled a report from contractors that is going to assist us establish who the real owners are." "That way we are going to make sure we issue title deeds to the rightful owners." Four suspects were arrested by members of the Hawks Serious Commercial Crime Investigation team on Wednesday 13 August 2021 for fraud, corruption, theft, forgery and money laundering. Vusumuzi Phakane (52) Emalahleni municipality official, Justice Sambo (46) and Caroline

# **EMALAHLENI CORRUPTION**

Koloane (29) appeared before the Emalahleni Magistrate Court on Friday 13 August 2021. It is alleged that during October 2020 the accused Phakane who is employed by Municipality as Community Municipal Coordinator had access to information on RDP houses around Emalahleni and colluded with Sambo to sell those houses. The two approached Kgoalane and used her as the advetiser. The unsuspecting victims would respond to the advert seen on social media and be directed by the syndicate to the Municipality offices to complete the agreement of sale forms. They would be further advised to go to the lawyers for the agreement and the victims became convinced that the sale is legitimate. They would be told to make the payment into Sambo's Nedbank account. The syndicate allegedly shared the money amongst themselves. Whilst the victim occupies the newly purchased house, other victims would also come and produce documents as proof of purchase for the same house. The victims lost approximately R300 000.00 The

matter was reported to the Hawks for investigation. During the investigation it was established that the lawful owners of the houses is still alive. The suspects were linked to the allegations, traced and arrested. The three suspects appeared in court, Phakane and Kgoalane were released on R10 000 bail each while Sambo was remanded in custody because he has previous convictions. The case was postponed to 20 August 2021 for Sambo's formal bail applications. The Provincial Head of the Directorate For Priority Crime Investigation, Major General Zodwa Mokoena warned the public about the scamers who are unlawfully selling the Government houses. She further retiliated that there is no way that the government houses can be sold. The public is therefore encouraged to report such types of incidents," she said.

# EMALAHLENI TO BE INVESTIGATED

The Minister of CoGTA, Nkosazana Dlamini-Zuma has directed the Mpumalanga CoGTA department to investigate eMalahleni municipality over allegations of paying its municipal manager and section 56 managers at maximum limits for a category 6 municipality. This comes after Dlamini-Zuma, through a written reply to a question by DA's Sonja Boshoff, found that remuneration packages of the municipal manager and other six senior managers were above the gazetted threshold. It was revealed that the municipal manager, for the 2017/18 financial year, was paid R1,9 87 402 instead of a prescribed

R1,464 332 a year while the other senior managers were paid between R1 415 047 and R1 596 747 a year. According to the Municipal Systems Act of 2000, the upper limits of the annual remuneration packages payable to category 6 municipal managers is R1 464 332 and R1 188 638 for managers directly accountable to municipal managers. "It is evident that the municipal manager and all senior managers are remunerated above the prescribed threshold," she said in a statement. "This action contravene the Notice and constitutes an overpayment in terms of item 11 (1) of the Notice. Item 11 (1) of the Notice enjoins the municipality to recover any overpayment arising from

the implementation of the Notice."
"As the malpractice has only been brought to the attention of the Minister, it is submitted that the MEC for CoGTA in Mpumalanga be requested to institute corrective measures in this regard," she said. Department's spokesperson, Lindiwe Msibi said investigators have already been dispatched to Emalahleni. "The MEC has intervened in terms of section 106 (1) (b) of the Municipal Systems Act in the municipality. An investigation team has been appointed in terms of the mentioned legislation to investigate these allegations," she said.

"The department will allow the legal processes to play out, and those

recommendations will be implemented without fear or favour on all those implicated in order to recover what the Municipality has lost, from their current incomes or pensions," Msibi said. Sonja Boshoff, DA member of the National Council of Provinces (NCOP). they want the councillors who approved this irregular expenditure should also be held accountable as they were aware that they are in contravention of the notice. "Furthermore, the provincial MEC for CoGTA, Busisiwe Shiba, should also be held to account as it is clear that she has no idea of what is going on in her department or at this municipality," she said.
