PRESIDENTS RAMAPHOSA AND MASISI **VISIT SITE OF TRAGIC BUS CRASH**

Mokopane, Limpopo – Presidents Cyril Ramaphosa of South Africa and Mokgweetsi Masisi of Botswana made a solemn visit to the site of a tragic bus crash that claimed the lives of 45 Botswana nationals on Thursday.

The incident occurred on March 28, 2024, when a bus carrying Botswana citizens to the Saint Engenas ZCC Easter conference in Moria, Polokwane, crashed near the Mmamatlakala Bridge along the R518 route in Limpopo.

During the visit, both presidents received a full briefing on the status of identification and DNA processes of the deceased at the Mogalakwena Municipali-

They then proceeded to the crash site at Mmamatlakala Bridge to pay their respects to the victims.

The tragic incident left 45 Botswana nationals dead, with the sole survivor being 8-year-old Lorraine Atlang Siako, a Standard 4 learner.

Lorraine was treated medically and survived the crash despite the horrors she had experienced.

After being released from a Limpopo hospital, she was escorted by medical professionals, such as Minister of Health

Dr. Joe Phaahla and Limpopo MEC of Health Dr. Phophi Ramathuba, to return to Botswana.

President Ramaphosa conveyed condolences on behalf of the South African government to Botswana, expressing sorrow over the loss of lives in the crash.

Both presidents expressed gratitude to emergency personnel and government officials who responded to the scene.

Investigations into the cause of the crash are ongoing, with preliminary findings suggesting human error. Meanwhile, efforts to identify the deceased are progressing, with six bodies positively identified and ready for repatriation.

The process of identifying the remaining deceased is underway, with authorities working swiftly to provide closure to the families.

Residents of Mmamatlakala village have called for road improvements to prevent future tragedies, emphasising the need for enhanced safety measures.

The visit by Presidents Ramaphosa and Masisi underscores the importance of cooperation between South Africa and Botswana in times of crisis, as both nations mourn the loss of lives and work together to support the affected families.



MAYOR OFFERS SUPPORT TO FAMILIES

AFFECTED BY TRAGIC ACCIDENT

Maserumule Park, Limpopo - In the wake of a devastating accident that claimed the lives of four individuals from two families in Maserumule Park, Makhuduthamaga Mayor Merah Masekwele Mahlase

extended her condolences and support to the grieving families.

The tragic incident occurred on Easter Sunday, March 31, 2024, along Maserumule Park Road, leaving the community and two families reeling from the loss.

Mayor Mahlase visited the Mosotho family in Riverside B, Ward 9, and the

Makunyane family in Maserumule Park, Ward 5, to offer comfort and solidarity during this difficult time.

Among the victims were Assistant Inspector of Booysendal Mining Company, Johannes Pholwane Mosotho (40) and his brother David Phai Mosotho (37) who was an employee.

The Mosotho brothers were the sole providers for their household, leaving behind a profound void in their family.

Additionally, Elias and Doris Makunyane, prominent figures in the community, were also tragically lost in the accident.

Elias Makunyane was a dedicated educator and community leader, known for his commitment to education and his involvement in various community organisations, including the South African Democratic Teachers Union (SADTU).

Expressing her condolences on behalf of the government, Mayor Mahlase described the accident as a disaster requiring collective action from all sectors. "We offer our support to the bereaved families as they navigate through this most difficult period," she stated.

The Executive Mayor of Sekhukhune County, Honourable Cllr Minah Bahula, and National Council of Provinces (NCOP) member Dr. Dickson Namane Masemola also offered their support to the affected families, emphasising the importance of community solidarity in times of tragedy.

During her visit, Mayor Mahlase encouraged relatives and community leaders to collaborate in providing support and assistance to the surviving children, particularly in ensuring their continued education

Mbombela, Mpumalanga – Mandla Msibi, the Treasurer of the African National Congress (ANC) in Mpumalanga, has been suspended by the party following allegations of sabotage during the January 8 rally celebration at Mbombela Stadium.

The ANC's decisive action comes after Msibi was found guilty of misconduct and incitement against President Cyril Ramaphosa.

The suspension, which will last for three years with conditional terms, aims to address Msibi's actions and uphold party discipline.

This development has sparked concerns about internal dynamics within the ANC leadership in Mpumalanga.

Provincial Secretary Muzi Chirwa announced the suspension during a media

briefing at the ANC provincial offices in Mbombela.

Additionally, Sibusiso Buddha Mdluli, Msibi's chief of staff, has been expelled from the ANC, while Mandla Mhlanga has been declared not guilty.

This is not Msibi's first brush with controversy. In 2021, he was asked to step aside from his position as Mpumalanga Agriculture MEC due to facing murder and attempted murder charges related to a shooting incident in August of that year.

However, in September 2022, the murder charges against him were provisionally withdrawn by the National Prosecuting Authority (NPA) in the Mpumalanga Division of the High Court in Mbombela, leading to his reinstatement as MEC for Co-Operative Governance and Traditional Affairs (COGTA).

SIU HALTS SALE OF FARM LINKED TO MISAPPROPRIATED NLC FUNDS

Limpopo - The Special Investigating Unit (SIU) has secured an interdict from the Special Tribunal to halt the sale of a farm in Limpopo linked to former National Lotteries Commission (NLC) Chief Operations Officer Phillemon Ledwaba and his brother Johannes Ledwaba.

The farm, valued at R7 million and currently under offer for R5 million, is subject to preservation pending the outcome of a civil action by the SIU.

In an order dated 28 March 2024, the Special Tribunal prohibited the Ledwaba brothers and any other party from selling, transferring, or dealing with the farm in any manner.

The farm, registered under the Mosokoti Business Trust controlled by the Ledwaba brothers, was purchased using funds traced back to the NLC.

The SIU initiated its investigation

following a tip-off about the sale of the farm and its connection to misappropriated NLC funds.

The investigation uncovered a complex web of transactions involving NLC-funded organizations and entities linked to Ledwaba.

One such organization, Lulamisa Community Development Organisation NPO, received substantial grant funding from the NLC, part of which was diverted to Iron Bridge Travelling Agency, owned by Ledwaba's wife.

Funds subsequently flowed through various entities before being used to purchase the farm.

Similarly, funds earmarked for Tshikovha Graduate Academy were redirected to companies associated with Ledwaba's cousin, ultimately facilitating the purchase of the farm.

The SIU's evidence suggests that Ledwaba violated the NLC's conflict of interest clause and misappropriated funds for personal gain.

The interdict forms part of the SIU's efforts to recover assets lost due to alleged corruption or negligence within state institutions.

President Cyril Ramaphosa authorized the SIU to investigate allegations of corruption and maladministration within the NLC, and to recover financial losses suffered by the state.

Kaizer Kganyago, spokesperson for the SIU, emphasized the organization's commitment to fighting corruption and seeking justice.

The SIU will pursue civil action in the Special Tribunal or the High Court to rectify any wrongdoing uncovered during its investigation.

ZANELE MKHONTO SENTENCED TO 20 YEARS PRISON FOR KILLING HER EX-COP BOY-FRIEND WITH HIS OWN GUN.

Mbombela, Mpumalanga — The Mpumalanga Division of the High Court sentenced 30-year-old Zanele Mkhonto to 20 years in prison on April 5th for the murder of Sergeant Mandlenkosi Happy Thwala, a former police officer assigned to the Ka Bokweni police station.

Mkhonto's conviction stems from the tragic killing of Sergeant Thwala, whose lifeless body was discovered near his residence in Gedlembane, Pienaar, Mpumalanga, with fatal gunshot wounds to his head and upper body.

The incident sent shockwaves through the community, shedding light on the dangers faced by law enforcement officers in their line of duty.

According to reports, Mkhonto and Sergeant Thwala were in a romantic relationship, having lived together from January to July 2022 in Gedlembane, Pienaar, and Mbombela.

However, the relationship turned volatile, prompting Mkhonto to leave for her parental home.

On August 2, 2022, Mkhonto visited Sergeant Thwala in Gedlembane, resulting in a heated altercation. Subsequently, while Thwala was asleep in bed, Mkhonto took his service pistol and fatally shot him multiple times.

"After committing the crime, Mkhonto fled the scene, taking the deceased's firearm and vehicle," stated Monica Nyuswa, spokesperson for the National Prosecuting Authority (NPA) in Mpumalanga

langa.
"She later discarded the firearm at a roadblock in Zwelisha, near KaBokweni, before returning home to Masoyi, where she confessed to a friend.

The police were alerted, and Mkhonto was subsequently arrested."
Phindile Mashaba, a representative of the Thwala family, expressed relief at the sentencing, albeit amid ongoing mourning.

"My brother did not deserve to meet such a tragic end, with his body being discarded in the bushes. It's heart-wrenching for our family.

We have long awaited justice, and now it has been served."

Mashaba cherished her memories of Sergeant Thwala, who was well-liked by many in the community and was a modest

man with a wonderful sense of humour.
"We will always miss him dearly," she

The case serves as a grim reminder of the consequences of domestic violence and the importance of seeking help in volatile situations.

TRUCK DRIVERS AT KOMATIPOORT LEBOMBO

BORDER FACE RISING CRIMINAL THREATS

Emalahleni, Mpumalanga - Five suspected cash-in-transit (CIT) robbers met their demise in a fierce gun battle with Mpumalanga police on Wednesday last week.

The exchange of gunfire occurred in Tasbet Park, Emalahleni, during a high-stakes operation.

According to Police Spokesperson, Lieutenant Colonel Mavela Masondo, law enforcement received intelligence regarding CIT robbery suspects en route to Mpumalanga.

"Further information indicated an attempted robbery unfolding in Witbank," Masondo stated. Acting swiftly, the police tracked the suspects to a safe house in Tasbet Park.

As officers closed in on the residence, the suspects, driving a Toyota Quantum, detected the police presence and initiated gunfire.

In response, both police and private security personnel engaged the suspects in a fierce firefight.

The intensity of the exchange resulted in the fatal shooting of five suspects on the scene.

Additionally, eight suspects were

apprehended and taken into custody, while approximately nine others managed to evade capture, fleeing from the scene unharmed.

Masondo disclosed that authorities recovered an arsenal of weaponry from the scene, including five rifles and two pistols, along with four vehicles.

These vehicles, he noted, were linked to previous hijackings in various areas of Gauteng.

Among the hijacked vehicles were a

Among the hijacked vehicles were a Mazda CX5 involved in a case in Jeppe, an Audi Q5 stolen in Yeoville, and a Haval taken in Rabie Ridge. Another Mazda CX5 was discovered

Another Mazda CX5 was discovered with a tampered engine number, further complicating the investigation.

The apprehended suspects are set to face a litany of charges, including murder, attempted murder, and possession of prohibited and unlicensed firearms and ammunition, in addition to CIT-related offences.

As investigations continue into this deadly confrontation, the incident serves as a stark reminder of the dangers posed by CIT robberies and the unwavering commitment of law enforcement to combat such criminal activities.

POLICE SEIZE MINING EQUIPMENT DURING OPERATION VALA UMGODI

Sabie, Mpumalanga - In a concerted effort to combat illegal mining activities, a multi-disciplinary police team deployed for Operation Vala Umgodi achieved significant success on Thursday last week.

This operation targeted Sabie, where illegal mining operations were reportedly rampant, with a particular focus on the Sabie informal settlements.

The team's diligent efforts led to the seizure of 36 Phendukas, 8 gas bottles, 5 gas regulators, and a cutting torch.

Upon their arrival, numerous suspected illegal miners fled into the bushy river banks, evading apprehension. However, the confiscation of mining equipment marks a crucial step in disrupting illegal mining activities in the area.

The Provincial Commissioner of the SAPS in Mpumalanga, Lieutenant General Semakaleng Daphney Manamela, commended the team for their resolute actions in addressing illegal mining operations.

"We will continue these disruptive activities until we put a complete end to illegal mining activities everywhere," affirmed General Manamela.

During the demolition, police ensured the safety of both the working team and the community, prioritising the prevention of harm throughout the process.

Temporary structures identified as sites for illegal mining operations were found vacant, with mining equipment such as Phendukas and gas bottles seized from the majority of these structures.

Notably, police uncovered a Phenduka hidden beneath the soil in one of the structures, highlighting the covert nature of these illegal activities.

Provincial Commissioner Lieutenant General Semakaleng Daphney Manamela reaffirmed the commitment of police and other stakeholders to eradicate illegal mining, emphasising that such criminal activities have no place in the community.

As Operation Vala Umgodi continues, authorities remain steadfast in their resolve to stamp out illegal mining operations and uphold the rule of law.

Komatipoort, Mpumalanga - Truck drivers operating at the Komatipoort Lebombo border in Nkomazi, Mpumalanga, are facing escalating security threats as they transport valuable commodities to Mozambique, with reports indicating prolonged waiting times and vulnerability to criminal attacks.

Truck drivers, responsible for transporting goods such as coal, iron ore, and manganese to Mozambique, often find themselves stranded at the border gate for days, enduring extreme heat and security risks

Criminal gangs, particularly from the nearby town of Ressano Garcia in Mozambique, have targeted these drivers, leading to robberies, harassment, and even fatalities.

Bongani Nyundu, a trucker, emphasized the urgent need for 24-hour patrol teams to ensure the safety of drivers not only at the border post but also along the N4 highway where trucks queue.

He revealed that over twelve freight truckers have fallen victim to criminal activities this year alone. Vusi Nyathikazi, transporting coal from South Africa to Mozambique, highlighted the challenges faced by drivers during nighttime queues, including lack of access to facilities and safety concerns.


The queue at the Lebombo border post extends up to 16 kilometers, exacerbating the vulnerability of drivers to criminal elements.

The lack of 24-hour operations at the border crossing has led to increased crossing times, causing traffic congestion and headaches for residents of Komatipoort, Malelane, and KamaQheke-

Gugu Ngwenya, a resident, expressed concerns over the damage caused to roads by heavy truck traffic, particularly during peak periods.

As truck drivers continue to endure security threats and logistical challenges at the Komatipoort Lebombo border, stakeholders are urged to implement measures to safeguard the well-being of drivers and ensure the efficient flow of goods across the border.

Soweto, Johannesburg - Six suspects have been apprehended in connection with the horrific kidnapping and killing of a well-known Kaizer Chiefs football player, marking a major breakthrough in the investigation team under the direction of Lieutenant General Tommy Mthombeni, the Gauteng Provincial Commissioner.

The tragic incident, which shook the soccer community, occurred last week on Wednesday when the 24-year-old Premiership player fell victim to a fatal attack in Honeydew.

According to reports from the Gauteng Provincial Police Office, the victim, driving a red VW Golf 8 GTI, had innocently pulled into a petrol station on 14th Avenue, corner Hendrik Potgieter, awaiting service.

However, his routine errand swiftly

turned into a nightmare as two armed assailants arriving in a white BMW 1 Series accosted him.

Brandishing firearms, they forcibly removed him from his vehicle before callously shooting him in the upper

Subsequently, the suspects callously absconded with the victim's vehicle, leaving behind a trail of shock and grief.

Despite the swift emergency response and the victim being rushed to the nearest medical facility, his injuries proved fatal, marking a tragic end to a promising career and leaving the soccer fraternity in mourning.

In the aftermath of this despicable crime, the Gauteng Provincial Commissioner took decisive action, mobilising a specialised task force comprising seasoned detectives and law enforcement agencies.

Their relentless pursuit of justice

culminated in the apprehension of six suspects in Slovoville, Soweto, during the early hours of Wednesday.

Furthermore, authorities successfully recovered the victim's vehicle, albeit stripped, on Monday.

Investigations have unveiled a sinister nexus, suggesting the arrested individuals may be part of a broader syndicate implicated in car hijackings across Gauteng

While the immediate apprehension represents a significant breakthrough, law enforcement remains vigilant, with ongoing efforts to identify and apprehend any additional suspects.

The collaborative efforts of the investigative team, under the leadership of Gauteng Deputy Provincial Commissioner Crime Detection Major General Mbuso Khumalo, underscore the unwavering commitment to ensuring perpetrators of such reprehensible acts

are swiftly brought to justice.
The arrested suspects; Ndumiso
Moswane (26), Fernando Sive (25),
Nhlakanipho Dlamini (21), Franky (25), Maredi Mphahlele (36) and Thembinkosi Hlomikhawu (31) are scheduled to appear before the Roode-poort Magistrate's Court on Friday, facing charges related to murder and car

hijacking.
In light of this development, the
Gauteng Provincial Police Commissioner extends appreciation to all law-abiding citizens who provided invaluable information and support throughout the investigation

However, the appeal for assistance remains open, urging anyone with pertinent information to come forward and aid in the ongoing pursuit of justice.

As the soccer fraternity mourns the untimely loss of one of its own, the resolve to combat such criminality and uphold the sanctity of sport remains resolute.
