### Nathi Mthethwa's **Mysterious Death** in Paris Sparks Controversy

outh Africa - The shocking death South African Diplomat has left Paris baffled and authorities investigating.

Nkosinathi Emmanuel Mthethwa. South Africa's Ambassador to France, was found dead outside a hotel in Paris on Tuesday morning.

On the evening before his death, Mthethwa sent a distress message to his wife around 9:30 pm, expressing fear and regret. "His apologies and his intention to end his life"

were part of that message, according to media reports.

The next day at 11:10 am, a security guard found him dead outside the Hyatt Regency Paris Étoile, a hotel located about 3.5 kilometers from the South African embassy. Authorities are now investigating whether the Diplomat's death was a deliberate act or something more sinister.

The police have not yet confirmed if Mthethwa jumped from the hotel's 22nd floor, but initial investigations suggest it could have been a planned act. No signs of struggle or drug use have been could be a carefully staged incident. The circumstances surrounding his death are under scrutiny, especially since his wife reported his disappearance a day earlier. "He left our home to attend a cocktail party but later went to the hotel, where he had booked a room ten days earlier", she said. French investigators are also looking into whether Mthethwa had been under surveillance. It is believed that security

### R2 BILLION STOLEN FROM TEMBISA HOSPITAL IN HEALTHCARE SCAM

**Lembisa** — The Special Investigating Unit (SIU) has revealed a shocking case of corruption and theft involving more than R2 billion in funds intended for healthcare services at Tembisa Hospital. The investigation uncovered three major syndicates accused of siphoning off the money through fraud, corruption, and money laundering. In a recent report, SIU head Andy Mothibi explained how officials and service providers manipulated procurement processes for personal gain. "We have identified irregularities, fraudulent activities, and corrupt practices by officials and service providers," said Mothibi. Although the investigation is ongoing, early findings point to a complex web of illegal activities. The SIU, working closely with the Office of the Gauteng Premier, has identified three main syndicates: Maumela Syndicate: Linked to Hangwani Morgan Maumela, this group is responsible for R816 million in irregular procurement. Assets linked to Maumela include luxury vehicles and properties in Bantry Bay, Sandton, and Zimbali, collectively valued at over R520 million. Several properties and high-end cars, including Lamborghinis and Bentleys, have already been seized. Mazibuko Syndicate: Associated with Rudolph Mazibuko, this group controlled assets worth R42 million, including

properties in Gauteng and the Western Cape.

Syndicate X: Comprised of several smaller groups, this network is linked to R596 million in procurement fraud, with assets estimated at R150 million. The investigation has also implicated at least 15 current and former officials from the Gauteng Department of Health and Tembisa Hospital. They stand accused of accepting bribes, money laundering, and bid rigging. So far, 116 disciplinary referrals have been made against 13 officials, with some also facing civil litigation.

The syndicates' modus operandi included falsified procurement documents, collusion between service providers and officials, and splitting contracts to bypass proper bidding processes. Funds were often channeled to front companies or intermediaries, with no goods or services delivered.

"All the money went from the hospital to fronts and beneficiaries," the SIU said. The SIU is now working to recover stolen assets and plans to continue its investigation until November 2027. The agency also cautioned that senior officials may be implicated and called for stricter vetting and oversight to curb future corruption. "This betrayal of trust is unacceptable. We will pursue every cent stolen and ensure justice is served," Mothibi declared.

#### HOSPITAL CLEANER ARRESTED FOR SELLING HUMAN PLACENTAS, GRANTED R10K BAIL

ydenburg — Rose Mnisi, a cleaner at Lydenburg Hospital in Mpumalanga, was granted ■bail of R10,000 after being caught allegedly trying to sell human placentas. Police found her carrying a plastic bag containing an undisclosed number of placentas during routine patrols. According to police, Mnisi was hitchhiking in the Nelspruit area when she was stopped and arrested last week. She admitted to working as a cleaner in the maternity ward of the hospital. Police allege Mnisi was looking for buyers for the placentas and was apprehended following a tip-off. Her case remains under investigation. Although the exact intended use of the placentas is unknown, authorities

suspect they may have been linked to

illegal activities involving traditional rituals.

The Mpumalanga Department of Health welcomed the swift police action. MEC for Health, Sasekani Manzini, praised law enforcement, stating: "The department will continue investigating this case

until the end and hopefully bring light to what transpired." This is not the first incident involving human body parts in South Africa. Earlier this month, a Mozambican traditional healer appeared in court in Tshwane after police found human remains in his possession. Investigators believe those parts were linked to violent crimes. Mnisi faces charges of illegal possession of human tissue. Her case has been postponed to November 4 for further investigation. In the meantime, the Department of Health has formally suspended her.

his movements before he died.

Some reports suggest that the diplomat's phone was last used at Bois de Boulogne, a large park in Paris, which could provide further evidence. Mthethwa, was a well-known politician in South Africa. He had a long career, starting in the anti-Apartheid struggle and later holding important government roles.

He was the organizing secretary of the ANC Youth League in 1994 and joined the South African National Assembly in 2002. In 2008, he became Minister of Safety and Security before moving to his diplomatic role in France. His career was marked by public service and strong political influence. Lieutenant-General Nhlanhla Mkhwanazi mentioned Mthethwa during his testimony

at the Madlanga Commission of Inquiry. Mthethwa held the position of Police Minister from May 11, 2009, to May 25, 2014. Adding to the intrigue, KwaZulu-Natal Police Commissioner claimed that Mthethwa pressured Faith Radebe, the former Inspector-General of Intelligence, to drop a criminal case against Richard Mdluli. Mdluli used to head Crime Intelligence and was accused of misusing the police's secret fund for personal trips and using police safe houses for himself. A detailed review of his phone records, security footage, and personal communications is underway to uncover what led to this tragic event. This is a developing story as investigations continue.

## POLICE OFFICER JAILED FOR MURDER AND PLANTING DRUGS IN VICTIM'S CAR

olokwane: A police officer found guilty of murder after shooting a suspected drug peddler at a traffic robot has been sentenced to 15 years' imprisonment by the Limpopo High Court sitting in Polokwane. The court heard that Avhahumi Adolphus Netshikweta (41), attached to the police's Highway Patrol Unit, was on duty with his colleagues when they received a false tip-off about a man distributing drugs in the Lebowakgomo area. The officers later spotted a VW Polo matching the description provided and gave chase.

The driver of the VW Polo, Thlompho Mabiletja, unaware that the officers were pursuing him, stopped at the robot. The police instructed him to switch off the engine and, while he was still complying, Netshikweta shot him dead. Upon searching the deceased's car, police initially claimed to have found drugs, money, and a toy gun. However, during the

trial, the State proved that the items were planted to justify the killing. "This followed a thorough investigation by the Independent Police Investigative Directorate (IPID), which led to a murder case being opened against Netshikweta," said Limpopo National Prosecuting Authority spokesperson Mashudu Malabi-Dzhangi. In aggravation of sentence, Advocate Andisa Vavilova Mudau for the State argued that the accused was the aggressor on the day of the incident and that the deceased had done nothing to warrant losing his life. Mudau further submitted that Netshikweta still faces two pending cases of assault with intent to cause grievous bodily harm. "The accused is a law enforcement officer and, as such, his conduct has brought the criminal justice system into disrepute. His actions violated the South African Constitution, which he had taken an oath to protect and serve," Mudau added. The court sentenced Netshikweta to 15 years' direct imprisonment for murder.

# MAN WHO RAPED A MINOR SENTENCED TO LIFE IMPRISONMENT

olokwane: A 44-year-old man who abducted and raped a minor girl at a village outside Polokwane has been sentenced to life imprisonment by the Seshego Magistrate's Court. The court heard that Poulis Ngoepe spotted the child at night while she was fetching water outside her family home in Ga-Ramoshoana village. He followed her, covered her mouth with his hand, and dragged her to his residence. There. he repeatedly raped her while threatening to kill her if she told anyone about what he described as "their love affair." The next day, Ngoepe released the girl but warned her to remain silent. However, she confided in her grandmother, who immediately reported the matter to Matlala Police. The case was

transferred to the Seshego Family Violence, Child Protection and Sexual Offences Unit for further investigation. Limpopo police spokesperson Brigadier Hlulani Mashaba said: "The meticulous investigation by Sergeant Victor Mokhudu led to the accused being arrested and charged with rape. Although he was released on bail, he was ultimately found guilty and sentenced to life imprisonment." Acting Provincial Police Commissioner Major General Jan Scheepers welcomed the ruling. "The sentence reflects the seriousness of the offence and the commitment of the justice system to protecting vulnerable members of our society," he said. The victim's family expressed relief, saying the rapist would "rot in jail."

# LIMPOPO PREMIER TO MEET FAMILIES OF 12 KILLED IN MULTI-VEHICLE COALITION

odjadjiskloof: Limpopo Premier Dr. Phophi Ramathuba has expressed shock at the deaths of 12 people, including a taxi driver, who lost their lives in a collision involving a minibus taxi, two trucks, and a bakkie at Ga-Sekgopo on Saturday.

"The news of this tragic accident is deeply touching, particularly when we consider the mothers and families affected by this loss. The provincial government stands in solidarity with the families during this difficult time, and we are prepared to provide the necessary support," said Ramathuba.

Among the victims was a six-year-old girl, one of 11 females who died alongside the male driver in the horror crash on the mountainous R81 Munnik Road.

According to provincial government spokesperson Ndavhe Ramakuela,

the premier, along with Transport and Community Safety MEC Violet Mathye and Health MEC Dieketseng Mashego, will meet the grieving families at Pietersburg Hospital Recreational Hall to assist with the painful task of identifying the deceased. Transport and Community Safety spokesperson Tidimalo Chuene said the cause of the crash is under investigation. However, preliminary reports received from officers who rushed to the scene state: "A Mercedes-Benz HMV truck with two attached trailers experienced brake failure and sideswiped a Mahindra LDV (bakkie). The truck then collided head-on with the rear of a Toyota minibus taxi and dragged it for about 150 metres until it crashed into another Mercedes-Benz HMV truck with a single trailer that was ahead." Traffic authorities confirmed there were no injuries in the two Mercedes-Benz HMV

trucks or the Mahindra bakkie.

#### ZIM MAN GETS 34 YEARS FOR POWER INFRASTRUCTURE SABOTAGE

usina — A Zimbabwean man who vandalised and stole power infrastructure on a farm was recently sentenced to 34 years' imprisonment by the Musina Regional Court, which also found he was in South Africa illegally.

Zakhele Hadebe, 51, and another man still

at large, opened a transformer and dug up several metres of underground cables supplying electricity to Maremani Nature Reserve, leaving wildlife and residents without power. The farm also suffered a water shortage, as the electricity that powered water-pumping machinery was cut, the court heard.

"While the second man managed to escape, Hadebe was arrested on site after being traced through their escape route. Throughout the trial, he admitted to being an illegal immigrant and to trespassing, but denied other charges, including tampering with essential infrastructure and theft of nonferrous metal," said National Prosecuting Authority (NPA) spokesperson in Limpopo,

State prosecutor Jan Krijt argued that infrastructure crimes were rampant across the country and particularly devastating to farmers as well as rural communities, who were often left without basic services. Krijt stressed that there were no compelling reasons for the court to deviate from the prescribed sentence of 34 years' imprisonment.

Mashudu Malabi-Dzhangi.

Advocate Ivy Thenga, director of the NPA in Limpopo, welcomed the prison term for Hadebe, saying crimes that targeted infrastructure deprived communities of basic services.

"The NPA will continue to adopt a focused approach to ensure that, upon conviction, harsher sentences are imposed. We also commend the sterling work of the prosecutor and the investigating police officers for securing conviction and sentence in this particular case," added Thenga.

# ALLEGATIONS OF POLITICAL INTERFERENCE UNCOVERED AT THE MADLANGA COMMISSION

retoria —The Madlanga
Commission of Inquiry, which
is investigating allegations of
misconduct and corruption within
the South African Police Service (SAPS),
continues to reveal tensions between law
enforcement officials and political leaders.
Recent testimonies from KwaZulu-Natal
Police Commissioner Lieutenant General
Nhlanhla Mkhwanazi and National Police
Commissioner General Fannie Masemola
have highlighted instances of interference
and breaches of protocol within the police
force.

During his testimony, Mkhwanazi discussed the precarious position of the Priority Crime Tactical Team (PKTT), stating that it faces potential disbandment due to factions within the state apparatus. He referred to a media briefing held on July 6, where he expressed his displeasure with the conduct of Members of Parliament, specifically Dianne Kohler Barnard and Fadiel Adams. Mkhwanazi accused Kohler Barnard of abusing her position by interfering with Crime Intelligence activities and claimed that Adams accessed sensitive information without authorization. Both MPs have denied these allegations, but they are scheduled to present their defense in the upcoming phase of the hearings. Mkhwanazi also detailed communications with Vusimuzi "Cat" Matlala and businessman Brown Mogotsi. He stated that Mogotsi had contacted him via WhatsApp concerning a smear campaign against him. Mogotsi provided police documents that should not have been accessible to civilians, raising concerns about the potential misuse of sensitive police information. Mkhwanazi further indicated that Mogotsi's comments suggested high-ranking officials were discussing matters that he, as a civilian, should not be privy to. He inferred that Police Minister Senzo Mchunu had shared excessive information with Mogotsi, indicating undue influence over the minister.

"We are fighting for the very existence of the PKTT against forces within the state apparatus," Mkhwanazi stated during his testimony, underscoring the challenges faced by the unit.

General Fannie Masemola's testimony on Monday and Tuesday temphasized the strained relationship between the SAPS and political leadership. He described Minister Mchunu's actions as "a total encroachment," cautioning that they violate Section 207 of the South African Constitution, which ensures operational independence for the police. Masemola expressed concern about the lack of communication regarding the PKTT's supposed disbandment, noting he had learned of it through WhatsApp while on leave. He defended the unit's operations and questioned the reliability of the information that informed Mchunu's decisions, raising issues of transparency and accountability.

"While the minister can set national policing objectives, operational decisions must rest with law enforcement leaders to maintain integrity and effectiveness," Masemola emphasized during his testimony. The Madlanga Commission serves as a crucial examination of the relationship between politics and policing in South Africa. The testimonies of Mkhwanazi and Masemola bring to light serious allegations of misconduct, unauthorized access to sensitive information, and the erosion of police independence due to political interference. As the commission progresses, its findings will play a significant role in shaping the future of the SAPS and in restoring public trust in law enforcement.

### HUNGRY LION GUTTED BY FIRE IN POLOKWANE

olokwane: Fast-food outlet Hungry Lion was gutted by fire on Monday at Excelsior Street in Polokwane, Limpopo, raising fears of possible job losses among employees who had only recently started working there after its grand opening less than a month ago.

According to eyewitnesses, the blaze broke out around midday, sending thick black smoke and flames high into the sky.

The inferno caused panic in the city while also drawing crowds of onlookers to the corner of Excelsior and Paul Kruger streets at Polokwane CBD's India Centre.

"Hungry Lion staged its grand opening just two weeks ago, and I had already submitted my CV. I fear it may have gone up in flames along with the food and equipment. It's hard luck for those who just got jobs — I wonder if they even received their first salaries yet," said a 22-year-old job seeker at the scene. Polokwane Municipality spokesperson Thipa Selala said no injuries had been reported.

"Municipal firefighters are still battling the blaze. What we know is that Hungry Lion and the adjacent clothing store, Tip Top, have been extensively damaged. We are monitoring the situation closely," Selala said. Provincial police spokesperson Brigadier

Hlulani Mashaba confirmed the fire but said details of the damages were still being compiled at the time of going to print.

Amid the chaos, looters were reported to have taken goods from nearby shops while others recorded videos and snapped pictures to share on social media.

Some eyewitnesses claimed the fire may have been caused by an iron left plugged in by owners of a nearby shop who had gone for midday prayers. Affected shop owners could not be reached for comment.

#### MPUMALANGA'S GOVT BOOSTS TRADITIONAL LEADERSHIP WITH VEHICLE SUPPORT

pumalanga — The Mpumalanga Department of Cooperative Governance and Traditional Affairs has handed over a new vehicle to Inkosi Themba Yende of the Ogenyani Traditional Council in Mkhondo. Yende, who also serves as Deputy Chairperson of the Provincial House of Traditional and Khoi-San Leaders (HTKL), received the vehicle as part of government efforts to ease transportation challenges for traditional leaders, particularly in rural areas. During the recent 2025/26 Policy and Budget Vote, the Department of Cooperative Governance, Human Settlements, and Traditional Affairs (CoGHSTA) announced an allocation of over R250 million for Traditional Leaders and R30 million for the House of Traditional Leaders.

MEC Speed Mashilo explained that the vehicle was more than a symbolic gesture. "It's a tool to help traditional leaders connect better with their people," he said, emphasizing government's commitment to supporting leaders like Inkosi Yende in their community duties and cultural events. Expressing his gratitude, Yende remarked: "Mpumalanga is the best province for supporting traditional leaders."

He welcomed the provision of resources that enable leaders to serve effectively. Government also announced restructuring measures under the Traditional and Khoi-San Leadership Act, recognizing five traditional councils and updating leadership roles.

ekhukhune: The two day voter registration drive for the coming by elections in the Fetakgomo-Tubatse Local Municipality in Sekhukhune district, Limpopo managed to attract some young potential voters.

ANC provincial spokesperson Jimmy Machaka said "We wish the elected councillor well and urge him to prioritise the services to the people of the ward. We also salute our volunteers, regional leadership

and the Provincial Executive Committee (PEC)."

The ANC retained the ward with 69.08% thus making its candidate Collis Nkwane Maleswene the ward councillor, the IEC confirmed.

EFF scored 23.60%, MKP 4.28% while SAMEBA got 1.99% in the hotly contested by election. Voter turnout was 48.87%, according to the IEC.

#### **NEW BOOK PROBES MALEMA'S WEALTH AND** POLITICAL POWER

Money. Power. Patronage.

outh Africa —A new book on Julius Malema is stirring debate across South

Africa. Malema: Money. Power. Patronage, by Journalists Micah Reddy and Pauli van Wyk, takes aim at the EFF leader's wealth and influence, questioning whether he is a champion of the poor or simply exploiting their trust.

The book alleges that Malema's fortuneestimated in the millions-is tied to political networks that keep the ruling elite in power. It claims he owns 10 luxury properties

MICAH REDDY & PAULI VAN WYK worth more than R21 million and lives a lifestyle far removed from his calls for economic iustice.

"Malema's empire is built on lies," the

authors write, suggesting he is another politician living in luxury while preaching poverty. They accuse him of looting funds meant for the poor, diverting money from

programs, and using it to bankroll his lifestyle. The story, they argue, mirrors that of other leaders who promise justice but protect their own wealth. Malema's true goal, the book suggests, is selfenrichment. Reactions have been swift. Supporters dismiss the book as a political smear, while critics say it confirms long-held suspicions. One reviewer summed it up bluntly: "Malema is just another politician in red overalls." Whether praised or condemned, the book forces South Africans to confront tough questions

about political promises,

### **BOTHLALE TEMA'S "LAND OF** MY ANCESTORS" REDEFINES **SOUTH AFRICAN HISTORY**

n Land of My Ancestors, Dr Bothlale Tema resurrects a silenced past that connects personal memory with South

Africa's broader historical wounds. What begins as nostalgic childhood recollections soon evolves into a powerful reckoning with slavery, land loss, and resilience. Tema grew up visiting Welgeval, a oncethriving farming community near Rustenburg. "Every weekend we would travel back to Welgeval, where I knew everyone and was related to nine out of ten people I encountered," she recalls. For her, this village was a place of warmth and belonging—until she unearthed a darker truth. While working on a UNESCO


project, Tema discovered her ancestors were not simply Dutch-speaking Africans but the descendants of slaves. Boer commandos had raided villages, seizing women and children—what they chillingly called "black ivory"—to work on farms in the western Transvaal.

"How did my people transform that amount of pain and trauma from their

past to produce me, who felt privileged by my upbringing?" she asks in one of the book's most haunting reflections. The book traces the community's struggles with land dispossession, from the 1913 Land Act to

their forced cession of land titles in the 20th century, culminating in 1980 when Bophuthatswana incorporated Welgeval into the Pilanesberg National Park. The loss of home was devastating, yet Tema frames it within a broader story of endurance. Reviewers hail the narrative for its dual lens—at once intimate and historical. Thekgo Raseala writes that the story of Polomane and Maja, Tema's forebears, "started something that could be passed down from generation to generation ... our ancestors were brave and strong and innovative in their years of life. They made a way and that is our heritage."


At less than 250 pages, "Land of My Ancestors" is both memoir and manifesto, reminding South Africans that confronting painful truths is essential to reclaiming dignity. Tema's journey ensures that Welgeval, though erased from the map, lives on in memory and history.
